

### 1999 Conservation Project

Garnet Range Moose Survey

Our chapter donated \$3500 along with securing a \$1042 grant from SCI national. This money was used to wrap up this survey and help finance the final report as well as pay for copter time for a count which took place on January 5 & 6, 2000. In 8 1/2 hrs. 44 moose were spotted.

## COHA

Our chapter has joined the Canadian Outdoor Heritage Alliance (COHA) in their fight for their lives to save hunting of all kinds in Canada. Our \$500 donation makes us a non-voting member. COHA is an organization of organizations and is growing very rapidly and is already reversing some of last years losses. And, yes, they will be there when we need them.

## Right to Hunt Amendment

Your Board of Directors has voted to investigate the possibility of our chapter spearheading a drive for a state constitutional amendment for the 'right to hunt and fish' for all residents of the state of Montana.

This would be a major undertaking and would ultimately have to involve all fishing and hunting organizations in the state. We are now in contact with Washington D. C. SCI office, Utah chapter, Idaho Chapter and others who have either passed such amendments or failed trying. Utah has a very strong amendment which it passed last year. We are looking at that as a model.

If we were to take on this important challenge and seriously take it to Helena and hope to get it passed; we would have to have some major help from our members. Once underway we would need continuing help from our chapter as well as the members of every organization who share this goal.

If you and I were to undertake this challenge it might just be the most important legislation to come down for a long time both past and in the future. It won't be easy, but if there ever is a time to do it, it is now before demographics change to the point of being impossible to pass. The Board will begin on this project December 2000.
